

## Rideau 2011 – “Where are We? Contest OFFICIAL CONTEST RULES

Contest is open to any individual over the age of majority and is a legal resident of Canada (excluding Quebec) or a legal resident of the United States (excluding where prohibited by law). All entries received will be considered; entries with the most correct responses will be entered into the final draw to win the prizes specified below.
